Business

 Police Chief Randall was present to announce the resignation of Patrolman Ryan Beausoleil. Chief Randall requested permission to start the process of filling this position by advertising for a part time and full time position. Chief Randall is compiling a wage study to present to the Board.

Action – The consensus of the Board was to have Chief Randall move forward with the hiring process; when the wage study is completed the Board will review and present it to the Union; Chief Randall is to work with Patrolman Beausoleil to complete his exit payout.

- Building Inspector the Board reviewed the situation and acknowledged the immediate need to take care of a number of outstanding issues
